Beyond these fun romps, I have responded to, or taken part in, some two dozen blogs about implementing the CCSS. Most enlightening, however, has been seeing exactly how my CSULB student teachers—and their cooperating teachers—have been phasing the CCSS into their daily lessons, in the Long Beach USD, the Los Angeles USD, and the Anaheim Union High School District. I would say that, generally, instruction ranges from well-outlined quarterly thematic Scope and Sequence units (with lots of teacher flexibility)—unto a pacing guide (“You had better be on page...”), depending upon the school site.

I still submit letters to various newspapers/publications about the CCSS; am taking the liberty of excerpting from my latest to the Long Beach Press-Telegram (in response to two recent front page articles done on the LBUSD CCSS implementation):

Letter to the Editor: Nadra Nittle’s excellent overview about just how the Common Core State Standards (CCSS) are being implemented locally left me with just a few lingering questions:

- If the CCSS were just freely adopted by those 45 states, why were federally funded Race To The Top monies linked to states’ developing and adopting common standards for K-12 schools? Some 11,000 of us managed to provide feedback during the narrow window, electronic access, time period for commenting on the two CCSS drafts. How many millions of stakeholders might have weighed in had a realistic time frame been provided? (See the AP article excerpt further on.)
- Why does college ready precede career ready? Is every student really college-bound before being work-bound?
- “In college [professors] don’t care what your opinion is. sounds very much like CCSS co-architect David Coleman’s assertion to the New York State Department of Education in April 2011, “As you grow up in this world, you realize people really don’t give a s__ about what you feel or what you think
- How can we reconcile this CCSS “biggest shift” in the last 20+ years with the fact that California demographic student composition has had its most dramatic change during the exact same period?

Bond Measure

California's state schools chief is backing a \$9 billion bond measure in 2014 to build up the technology infrastructure at K-12 campuses.

State Superintendent Tom Torlakson said Tuesday that California's schools must be prepared and outfitted to handle a dramatically new standardized testing system that will eventually require all students to be tested on computers rather than with pencils and fill-in-the-bubble sheets.

Bond money would not be used for devices like iPads, he said, but would focus on expanding and improving connectivity for all campuses. Assemblywoman Joan Buchanan (D-Alamo), is expected to sponsor the bill.

California prepares for Common Core standards

45 states and the District of Columbia will share K-12 goals set in the Common Core, which challenges teachers to offer more relevant, practical and rigorous lessons, and students to solve problems and think critically.

New standardized tests will debut in spring, so schools are training teachers, educating parents and purchasing materials and technology for the computer-only tests.

Fueled by \$1.25 billion from the state for the transition, a cadre of consultants and innovator teachers is showing colleagues how to rethink lessons and methods.

The standards cover only English and math, but spread responsibility for literacy to teachers of other subjects. Schools are free to decide what and how to teach, but their success will be measured on tests common to many states.

But in California, parents won't know how schools do, because for at least the first, and perhaps later, years, the state will not publish results of the successor to STAR exams, known as Smarter Balanced tests.

CTA Strategic Long-Term Planning

In early 2012 The California Teachers Association embarked upon a strategic planning process at the direction of its State Council of Education, and under the guidance of the Labor Education and Research Center (LERC) at the University of Oregon. The process – called “Your Voice, Our Union, Our Future” – has been designed to build a long-term plan for CTA that will engage all members and staff, look at what we are doing now and where we want to go, embrace new ideas, set priorities and focus organizational resources, and build the CTA we want for our future. The resulting strategic plan will be a “road map” for CTA’s future and will be voted upon at the January state council meeting.

CTA Sponsorship

CTA has approved \$4,000 sponsorship to CATE to help support a conference meal where needed. The check should already be in the mail. Also the Jim Clark award is given during The Equity and Human Rights conference which will be at the Marriott Hotel in Irvine, February 28-March 2, 2014.
