Maggie Potter, Megan Petersen, Susan Dillon, Michelle Berry, Liz McAninch, Anne Fristrom and I met in Santa Clara on May 8 with the hotel and convention center representatives to review plans for CATE 2013. They were excellent meetings and we accomplished a great deal in planning the convention. Many items discussed at these meetings will need to be discussed by the Convention Committee and the board at the September, 2012 meeting.

As a result of a proposal by Cheryl Smith, convention advisor, I have negotiated a contract with the Hyatt to allow CATE to count room pick-up at our 2012 board meetings against the minimum room minimum for CATE 2013. By holding the September board meeting at the Hyatt, we will reduce our minimum by 30 rooms, saving us money at the convention.

Carole LeCren has designed the flyer for 2013. It has been printed and Michelle will have copies for distribution to board members at the September board meeting.

I have one speaker lined up so far: Richard Lederer.

I have met with Michelle Berry and Punky and Anne Fristrom to discuss further issues, including how to do the program (printed) and the program (getting workshop presenters).

### **California English Editor Report      Carol Jago**

The first news I have already shared with the Board is that we have negotiated a reduction in publishing costs of \$500 per issue without any reduction in quality, pages, or color. The new costs will begin with the November issue.

This is very welcome news as ads are increasingly difficult to garner. The only luck I have had is to solicit Heinemann myself with ideas for their advertising particular books that are due out. I did this with the new Lucy Calkins book for September and plan to do the same for the new edition of Jim Burke's *English Companion* for November. We did receive a perfect unsolicited ad from a Native American curriculum development initiative for the September issue

Alas, although I submitted the December 2011 issue of *California English* focusing on evergreen ideas for teaching to NCTE it was not chosen. For next year I plan to submit the September issue on Native American Voices. It is hard to say what they are looking for.

I am currently well-stocked with artists thanks to all your assistance with leads.

In other CATE news, I will be speaking at 3 CATE councils this fall: Oct. 13 in Yuba City, Oct. 20 for Southland's fall conference in Whittier, and Oct. 27 for Promising Practices in San Diego.

At this time all of CTA's work is focused on the upcoming election.

Vote YES on 30 - Our Schools Need New Revenue!

In the past 4 years, more than \$20 billion has been cut from public education in California. We rank 47th in the nation in per-student funding and now have the largest class sizes in the

country. This year an additional \$8 billion in new cuts are being proposed. And without new revenue, an additional \$6 billion will be cut from public education.

CTA stands with the Governor in support of Proposition 30, the “Schools and Public Safety Protection Act”. It is the only funding initiative that takes care of the whole state by closing the budget deficit and paying down the state’s wall of debt, while providing billions for public schools and essential services. It does not raise income taxes on the poor or middle class.

Prop 30 is a tax on millionaires that asks the richest Californians to pay their fair share to help fund public education and other essential services.

- Individuals making below \$250,000 and families making below \$500,000 will pay NO additional income tax, so the middle class and poor are not impacted by the income tax increase.
- The revenue increases are temporary, with the income tax provisions lasting 7 years and the sales tax provisions lasting 4 years.
- Prop 30 guarantees that new revenues will go to education, bars funds for administrative costs and all funds are subject to an independent audit.
