

President's Report – September 2013

California lost two magnificent educators within days of each other this summer, Joan Owen and Michael Flachmann. These unexpected events occurred as I was enroute home at the end of a wonderful, extended road trip. Joan and Michael had a profound effect on their students and colleagues.

However, good news arrived from NCTE. Kristy Orona Ramirez has been named one of four State, Regional and Provincial Award winners of the 2013 NCTE/SLATE Affiliate Intellectual Freedom Awards. She will receive her award at the Affiliate Breakfast on Sunday, November 24 at NCTE in Boston. Tracy Sprague will be recognized as a 2013 High School Teacher of Excellence at the NCTE Secondary Luncheon on Saturday, November 23.

I received a letter from Barbara Cambridge, Director of NCTE/DC Office asking all the affiliates to reach out to our members of Congress on three issues:

- Support the National Humanities Council.
Proposed legislation would strip the National Humanities Council of up to 49% of its current budget. This cut would damage grants for humanities programs for K-12 and for colleges and universities. Legislators need to hear how important the humanities are via stories from our experience in practice and research.
- Vote to support Improving Literacy Instruction and Student Achievement (Senate ESEA 2013 Title IV, Part A)
This section of the proposed ESEA reauthorization in the Senate provides federal support for literacy programs, enhances each state's role in improving literacy instruction, and supports the creation of local high-quality literacy programs. We need to explain to our legislators what we need for effective literacy teaching and learning.
- Continue to fund the Striving Readers Comprehensive Literacy Program
This program is having a positive influence on K-12 literacy learning in the states that it funds. Appropriating equal funding for the future of this program is important. NCTE suggests that we share examples of the benefits of working with teachers in other subject areas and of aligning literacy objectives across grade levels.

I attended the recent Curriculum Study Commission meeting where we heard good news. The enrollment at the Asilomar Conference is up 15% over last year's numbers. The CSC also received a break when more rooms opened up in August. Since the school year began, they have received at least twenty more registrations. I hope this bodes well for CATE's numbers in February.

I look forward to another year of hard work alongside the tremendous group of individuals currently serving on this board.

Duties for this office include setting up the Advisory Board conference call, making room reservations, and arranging food and beverage service for the board meetings. I have completed all of the above, and, in addition, have made new name plates and badges. Denise Mikkonen – Member-at-Large Elementary

Over the summer I worked on our District Writing Team, refining the CC writing prompts and rubrics for elementary. We selected exemplars to post demonstrating a rubric 1, 2, 3 and 4 for grades K – 5 and provided annotations. The most interesting part was re-visiting the prompts we had written last summer and realizing how much we had all grown and learned about the Common Core as each trimester passed. We then went back and reworded the prompts to be more precise, aligned the rubrics k- 5 and started thinking about resources to provide teachers in the district. We are talking about working on “writing and math” as a district and what that would look like. Trying out some problems of the week in my class and having the students explain in writing how they solved the problem. For the high flyers they are explaining two ways to solve. In three weeks I can see how they are already progressing in their mathematical reasoning and ability to articulate in writing their process.

The SMWP summer camps went well, we had 9 camps for kids from first to High School in locations from Temecula, San Marcos to PUSD. The teachers loved the opportunity to team teach – we had great impromptu conversation about the implications of “race and teaching” with teachers from many different socio-economic areas and cultures. We passed out the CATE writing contest to campers.

In addition the SMWP had three day Common Core training with teachers from Calexico, Escondido, Oceanside, San Marcos and Temecula districts. The attendance was great over 40 folks some sessions. Such a wonderful way to see things from other points of view, and share ideas. Unwrapping the standards seems to be the biggest thing that districts are not doing – it seems to help with understanding the why and how of the standards and help folks to wrap their heads around each grade levels key points. My biggest ahha was when a teacher mentioned “You plan your whole curriculum around writing?” I hesitated and said. Yes. Suddenly the light bulb went off for me. They had considered writing something you did between 9:00 and 9:30, not integrating throughout the subject areas. I took the opportunity to encourage folks to attend CATE in February too!

Schools rising from budget depths, EdSource finds

With the passage of Proposition 30 and implementation of a new funding system channeling more money to most districts this fall, the 2012-13 school year will be the base for measuring how well schools recover from the Great Recession. Yet as EdSource documents in a report issued Thursday, there will be a steep climb out of the trough.

In “Recovering from the Recession: Pressures Ease on California’s Largest Districts, but Stresses Remain,” EdSource found signs that budgets were stabilizing and districts were regaining some ground after five years of damaging budget cuts. But there were also areas of further concern, such as a decline in the number of counselors in schools and a rise in rates of childhood poverty – evidence that districts continued to struggle, as measured by some key indices.

Honoring Teachers by giving various awards is one of the highlights of the CATE Convention each year. New and experienced teachers find this experience to be uplifting. Bill Foreman – MAL –College

Since May 2013 I've been working on developing new course material to align with the Common Core. In that I have benefitted from many discussions with CATE members and I appreciate their perspectives and input.

Recently, I have received news of a possible opportunity for Spring 2014. Our new president at CSU, Stanislaus announced a new emphasis on writing on our campus, as well as supporting efforts at community outreach. My department is responding to these announcements with plans to support the creation of writing centers at one or two local high schools. If successful, student participation in these writing centers could become part of the

Single Subject Matter Prep curriculum.

Additionally, my department chair would like us to sponsor a conference of some sort in regard to the Common Core. This would take place in late Spring 2014, and I would like to connect this effort to Central Council, giving us a major event for spring. At this point, the idea is only being suggested—funding and other necessary support has yet to be committed to the project.

This idea is only one of many being floated on my campus in hopes of gaining administration support. However, a conference on the implementation of the Common Core, particularly with regard to writing, aligns well with the priorities that leadership has set on my campus. We live in hope.

Since the May Board meeting:

- In June, submitted a classroom demonstration (foursome) proposal, "CCSS Future Illuminates Holocaust Past Via Readers' Theater," for the NCTE Convention--and got shot down;
- Monitored CCSS activities in a dozen Southwestern and Midwestern states during June 6556 mile auto trip;
- Wrote/had accepted for Fall/September *California English*, "Expanding Literary Nonfiction Incrementally";

- August 1st, attended a United Way of (in) L.A., designed by StudentsFirst, on Teacher Advocacy;

- August 18th, submitted a proposal, "Paying It Forward Via Nonfiction Holocaust Remembrances," for the CATE 2014 Convention;

- Will take part, on September 5th, in a Teacher Town Hall meeting at the Mark Taper Forum in the L.A. Central Library, sponsored by StudentsFirst.

Susan Dillon - CCCTE Representative

The Central Council is looking forward to our reception at Asilomar 62 this October. Steven Weinberg, Curriculum Study Commission registrar for the event, shared:

Last year we had 60 CATE memberships paid with registration, the year before that we had 55. This year we have 86 and we are still adding. I'm pretty sure we will get at least 4 more, which would be a 50% increase over last year.
