

2009 Annual Business Meeting
Santa Clara Marriott
Sunday, February 22, 2009

Berry moved and Delfino seconded to accept and adopt the agenda and the Rules of Conduct. MOTION CARRIED.

McAninch moved and Dunstan seconded to accept the minutes of the 2007 Annual Business Meeting in Fresno. MOTION CARRIED.

Chapman read his annual report.

Chapman announced that his report and the annual CATE report are posted on www.CATEweb.org

Berry explained the Rules for the CATE Elections: There are three different ways to vote. A member may vote at the end of the annual business meeting. Fifteen minutes after the meeting a ballot may be handed to Berry with a separate page listing name, etc. The second page is to verify you are a member and that you have voted so there will be no duplicate votes. The two other options are voting Online at CATEweb.org or by mail.

Cecil read CATE Resolution #2.

Cecil moved and Delfino seconded the approval of CATE Resolution #2: Eligibility for CAHSEE

Resolution: Therefore, let it be resolved that the California Association of Teachers of English (CATE) recommends the State Board of Education adopt a regulation allowing districts flexibility so that any student who takes CAHSEE as a 10th grader is automatically eligible to take any subsequent administrations of the test and protecting districts from any fiscal penalties for administration of the CAHSEE for these students. MOTION CARRIED.

Ledri-Aguilar read CATE Resolution #3.

Ledri-Aguilar moved and Dunstan seconded the approval of CATE Resolution #3 Drop-out categories.

Resolution: Therefore let it be resolved that the California Association of Teachers

of English (CATE) urges that the California Department of Education eliminate the term dropout for those students who have completed coursework but not not passed the CAHSEE. And let it be further resolved that CATE urges the California Department of Education establish a new category called “non-graduate” to describe those students. **MOTION CARRIED**

McLassen read CATE Resolution #4

McLassen moved and McAninch seconded the approval of CATE Resolution 4: Community College English Placement Tests

Therefore let it be resolved that the California Association of Teachers of English (CATE) supports efforts to ensure community college English placement tests reflect more closely how English Language Arts are being taught and assessed in the high schools so K-14 educators can work more collaboratively to support student success.

Jake Sanford of SCTE and Hockensmith seconded that the motion be tabled. MOTION DEFEATED.

Further discussion followed. The original MOTION WAS DEFEATED.

Williams moved and Hogue Smith seconded the approval of CATE Resolution 4: Community College English Placement Tests. MOTION DEFEATED

Ledri-Aguilar read CATE Resolution #5.

Ledri-Aguilar moved and Hogue Smith seconded approval of CATE Resolution #5: One Book, One City

Resolution: Therefore let it be resolved that the California Association of Teachers of English (CATE) commends the efforts of libraries and other organizations throughout the state to organize celebrations such as One Book, One City and encourages local councils to work with schools and libraries to promote and sponsor these events. MOTION CARRIED.

By-Laws Amendment

7.3.4 Eight (8) total Regular Members who shall serve as at-large members, three of whom shall be elected annually, except for 2007 and every three years thereafter, when two shall be elected, and shall serve for three years. They shall assume their offices on July 1 of the year in which they are elected. In order to accomplish greater diversity of the Board of Directors at all times, one (1) of these eight (8) Directors shall be affiliated with elementary school teaching (generally known as grades kindergarten through sixth grade); one (1) of these eight (8) Directors shall be affiliated with middle school teaching (generally known as grades sixth through eighth); two (2) of these eight (8) Directors shall be affiliated with high school teaching (generally known as grades ninth through twelfth), one (1) of these eight (8) Directors shall be affiliated with college teaching; and one (1) of these eight (8) Directors shall reside in a geographic region represented *by a Council Committee which has fewer than five hundred (500) Regular Members*. **Italicized phrase to be changed to: A council committee whose membership is less than 10% of the total CATE membership, as of September first of the previous year.**

Berry moved and Delfino seconded to accept the By-Laws Amendment. MOTION CARRIED

The word By was incorrectly struck and should not have been in the printing of the by-laws.

No new business.

Berry commended Delfino and McAninch for their fine work in presenting the highly successful conference.

Bob Infantino asked if the board would be commenting regarding the new budget legislation to the Legislature

Jean Wood of the Central Council announced the Asilomar Conference to be held October 2, 3, 4, 2009.
