President's Report

CATE 2011 Convention

I worked with Chair Michelle Berry on the CATE Convention 2011 in Sacramento. This convention was a great success, As President I had several duties. I arranged for the giving of awards, wrote letters notifying recipients, arranged for the time that each award would be given and selected the type of award, looking for the best type of award that would keep within the budget. I planned the President's Reception and the recognition of the Distinguished Service Award recipient and an appropriate gift which was difficult since the award was given posthumously. I also set the agenda and chaired the Annual Business Meeting. I worked with CYRM for the Saturday Luncheon and was able to secure Pam Munoz Ryan as the speaker.

Board Meetings

I planned the agendas and chaired the meetings. I worked with Vice President, Liz McAninch on the Advisory Conference Calls and gave the meeting agendas to Cindy Conlin to be posted on CATEWEB.

NCTE

I attended the NCTE Meeting in Chicago. I attended the Secondary Section Luncheon and the Affiliate Breakfast as a CATE representative. I also attended a session on improving Affiliate Websites and another session on building Student Affiliates. I also chaired the California scoring of the Young Writers contest; there was a significant increase in the number of students participating over the previous year.

CYRM

I attended the CYRM meeting with the intent of building a better relationship with CYRM. The goal is to improve communication between the two groups and to get more free books to give to teachers at the CYRM Luncheon at the CATE Convention. Also a new CATE Representative Vivian Boyd was appointed as a CYRM liaison. She will serve a three year term.

Addressing the Budget

CATE has made several attempts to respond to the increased worsening of the financial situation. The decreased financial support in all areas of education has had a negative effect on CATE. With careful planning we have been able to survive better than many other subject matter organizations. Creating a budget in May 2011 demanded more cuts. The President was the only CATE Board member to receive financial help to attend NCTE and that amount was cut by 50% over the previous year. The President's budget for travel, supplies and other items was also cut by 50%. The most devastating cuts resulted in reducing the number of issues of California English from five to four issues a year and in reducing the number of board meetings from four to three. It was decided that the May Board Meeting would be canceled as a two-day meeting where we would all meet in one place saving the cost of transportation, food and lodging for about 25 people. This meeting would happen as a virtual meeting that would take place via computer on one day.

Bob Chapman and I researched various options and decided on Cisco Web Ex as the program to pilot. We will try it for two Advisory meetings (about 10 people) prior to the May Meeting and then use it with the full board for the May Board Meeting.

CATE Registrar

We decided to replace Eddie Hase as CATE Registrar with Cindy Conlin who serves as CATE Web Master. I worked to help make this a smooth transition. We thank Eddie for the work he did for CATE.

Representing CATE

I believe that CATE should have representation at events sponsored by those groups who share our educational goals; however, with the present economic situation, it is impossible for CATE to pay board members for food, travel or housing to attend such functions. Therefore, we asked members who live in the area where the events take place to volunteer to attend these events to represent CATE. I attended the CETA Conference (California Educational Theater Assoc.) in Asilomar, NCTE in Chicago, and four meetings of the JCIM (Joint Committee on Instructional Materials at the SDE in Sacramento. I also attended the The Asilomar Conference sponsored by the Curriculum Study Commission. I planned to attend the CTA Good Teaching Conference but illness prevented me from going.

CATE had a busy year in 2011 with many joys and some disappointments caused by the economic downturn. However, CATE remains a strong organization with many dedicated members who work diligently for the success of its goals. Willing to make difficult but sound economic decisions, CATE will remain a positive force for English language arts teachers for many years to come.

Vice-President's ANNUAL REPORT

First of all, I extend a huge “thank you” to all the board members who made my job easier by your quick responses to room requests. In 2011, I negotiated bids from hotels for the board meetings in May, September and December. My special thanks to Punky Fristrom, who offered astute advice and counsel in handling hotel arrangements. I enjoyed the process of setting up rooms, arranging meeting space and selecting meal orders at the Town & Country Resort in San Diego, and the Doubletree Hotels in Ontario and Burlingame.

I have assisted with CATE 2012 by arranging the speakers for Two Minutes for CATE and those who introduce the presenters at meal events. I will also volunteer at registration and the CATE booth during the convention.

In my role as California Coordinator of the NCTE Achievement Awards in Writing, I distributed several hundred entries to a wide variety of readers – again, another enormous thanks to board members that volunteered to read and score student work. NCTE has instituted changes in both the Achievement Award in Writing and the Promising Young Writers. In hopes of both streamlining the process and attracting more entries, all work will be submitted online and all judging will be undertaken by online readers. NCTE eliminated state coordinators, but encourages everyone who has been a reader in the past to continue as an online scorer. However, we will no longer score California writers only, but also read essays from students across the country.

As Past President, I remain active on the Central Council Board. I joined other members of CCCTE as we hosted our annual Young Writers' Reception in Rist Hall at Mercy High School, San Francisco on Sunday, April 3. Over seventy-five guests, including writers, parents, teachers and friends filled the room. The hall echoed with laughter, applause and delight as we listened to an amazing array of young writers. The range and diversity of their work brought home the importance of CATE's writing contests in giving a voice to student writers. All of the students went home with books, gift cards and a certificate.

CCCTE funds scholarships for teachers to attend the Curriculum Study Commission conference at Asilomar through raffling tickets for Chiyo baskets and scholarships to CATE through tickets sales from Kathleen Cecil baskets. I donated material for the baskets, and assisted with the preparation and ticket selling. At CATE 2011, Central raffled tickets to the Cecil baskets and made enough money to sponsor several teachers to CATE 2012. In September, we also did very well at the CSC conference at Asilomar.

I served on the Leadership committee and chaired the Membership committee in 2011. I also served on the Advisory Committee and participated in the conference calls for planning meetings.

I hope to include electronic reminders in the coming year, and the new registrar and I met to discuss ways to improve roster data and accuracy, especially during convention.

During the convention, Membership booth volunteers assisted me to distribute our membership gifts of luggage tags to convention attendees. I provided council badges to attendees and have re-ordered them to distribute to the 2012 convention attendees.

I used the power point in the booth to display the variety of activities and people in CATE councils across the state and displayed posters to illustrate the councils. CATE board members were present to help greet convention attendees and collect leadership cards from members who would like to be more involved in the organization. Membership donated a free membership to the drawing at the annual business meeting.

Convention

Coordinator & Consultant Punky Fristrom

In spite of the bad economy, CATE 2013 was a fine convention under the direction of Chair Michelle Berry and her committee. The financial results were also much better than expected.

With help from Carrie Danielson and great design work by Carole LeCren, the program for CATE 2011 was designed, printed and distributed. Special thanks go to Registrar Eddie Hase. Program Chair Cheryl

Smith, Exhibits Manager Tammie Harvey and Precon Chair Jayne Marlink for their contributions to the success of the convention.

Meanwhile, work on CATE 2012 at the Ontario DoubleTree Hotel and the Ontario Convention Center has proceeded under the leadership of Convention Chairs Kim Flachmann and Jill Hamilton-Bunch and their local committee. Carole LeCren designed the flyer that was mailed in September and the January issue of California English will be a convention issue that will feature complete information about CATE 2012. Editor Carol Jago will include CATE 2012 information along with many of her regular features.

Following instructions from the board:

I renegotiated the contracts for CATE 2013 with the Santa Clara Convention Center and the Hyatt Regency Santa Clara in order to reduce CATE's liability because of the current financial situation. Later in the year, I signed another revised contract with the Santa Clara Convention Center. We have given up the exhibit hall on Thursday, which means move-in will be Thursday night. In return we received a change in the contract, which should give CATE a \$6,600 reimbursement, a delay in when deposits are due and a payment of \$4,000 from the company that will use the hall on Thursday. The contract with Curtin guarantees that the maximum we will pay extra for a night move-in in 2013 is \$4,000.

As a condition of receiving more favorable terms in the 2013 contracts, I signed contracts for CATE 2017 with the Hyatt Regency Santa Clara and the Santa Clara Convention Center.

I signed a contract with Curtin Convention and Exposition Services, Inc. to be CATE's exhibit hall decorator until 2016. Terms are the same as in the past years.

I am working with Michelle Berry and Cheryl Smith who have been appointed by the CATE Board as convention consultants and will become Convention Coordinators in the future.

The CATE Board appointed Cindy Conlin, who has been our webmaster, to be the registrar for CATE 2012. CATE Treasurer, Anne Fristrom, and I met with Cindy to review the registrar's duties. I have continued working with her as she takes on these new responsibilities.

California English Editor Carol Jago

Annual Report, 2011

California English is the professional journal of the California Association of Teachers of English. In 2011 the magazine published 4 issues focusing on the themes: "LGTB Issues in the Classroom," "What's in a List," (two issues), and "Evergreen Ideas for Teaching." Manuscripts for the journal are garnered through calls for manuscripts focusing on a particular theme and then sent out for online review. The calls are circulated through multiple electronic forums including the UCLA California Reading and Literature Project newsletter, the English Companion ning, and the NCTE web site.

Along with articles on teaching and learning, the journal includes news of CATE work in the field: conferences, resolutions, the CATE ballot, the CATE2011 convention program, and CATE writing contest winners.

In order to garner new reviewers for the journal, I present a session on California English at the convention in order to provide information to teachers interested in reviewing and/or in writing for our professional journal. All reviews are conducted via email, forwarding reviewers manuscripts that have been submitted online.

The quality of the manuscripts received has been consistently excellent. The editor has attempted to make the most of the magazine pages by asking writers to keep their articles under 2,000 words. This is increasingly important as we have — for economic reasons — reduced the number of pages in the magazine and reduced the number of issues for 2012 from five to four. Artists continue to be generous allowing California English to feature their work in California English.
