It is estimated that Supplementary Instructional Materials for English Learners will be \$21 per student.

Title 5 regulations for Instructional Materials were passed in January by the SBE and are now in the Office of Administrative Law for final review. These regs will take effect after the 2008 Reading/Language arts adoption.

Three people within the State have filed papers to run for State Superintendent—Tom Torlason, Gloria Romero, and Betty Karnette.

Additional nominations can be made by the CATE Board or by an individual via a petition containing at least 15 signatures by CATE members. Individuals can submit their petition and declare their candidacy up until two minutes before the beginning of the Annual Business Meeting on March 9, 2008 in Long Beach. All candidates will be given the opportunity to make a brief statement at the meeting.

Candidates' photos (digital) as well as written statements (100 words maximum) should be submitted to the Past President as soon as possible, but no later than immediately after the business meeting. Statements might include the candidate's educational philosophy, and the reasons they wish to serve on the CATE Board.

Members who wish to vote online will be referred to CATEweb.org to link to the online ballot which will also have the candidates' statements and a ballot to mark and submit electronically. Your votes will be received from your e-mail addresses and will contain your CATE membership identification number. Online submissions must be received by April 25, 2008.

Finally, the announcement of the 2008 election will be in the March issue of California English. Candidates' statements, photos, and a mail-in ballot will be included. You will find your membership number conveniently located on your address label. Because the convention is in March, the time to return the ballot by mail will be truncated in order to count the votes for submission to the CATE Board. Ballots submitted by mail must be postmarked no later than April 25, 2008.

A local committee will be formed to count votes taken at the business meeting, online, and by mail. The results will be submitted to the CATE Board for approval at the May meeting.

Each CATE member is entitled to one vote for the candidates of their choice. See the CATE By-Laws Sections 6:18-22 for details.

NCTE Liaison Report

The NCTE Annual Convention, "Because Shift Happens: Teaching in the Twenty-First Century" will be held on November 20-23, 2008 in San Antonio, Texas. CATE NCTE 2008 delegates will be approved at the May board meeting.

The 2008 NCTE Affiliate Leadership Meeting for regions 2, 4, 5 and 6 will be held on June 22-24, 2008 in Milwaukee, Wisconsin. Since CATE is a Region 3 affiliate, we won't send delegates this year.

The NCTE Annual Convention, "Mapping Diverse Literacies for the Twenty-First Century: Opportunities, Challenges, Promising New Directions" was held on November 15-18, 2007 in New York City. A resolution entitled, "Strengthening Teacher Knowledge of Lesbian, Gay, Bisexual, and Transgender (LGBT) Issues" was approved. The CATE Board applauds the formation and accomplishments of the NCTE Task Force to Advance and Support Members of Color. During the 2007 annual convention the executive board approved the recommendations made by the task force which includes a new award entitled the NCTE Early Career Educator of Color Leadership Award which will be given for the first time in 2008. Its purpose is to support early career (first five years in a paid teaching position) teachers of color who are willing to take part in a three-day summer leadership development conference that helps prepare them to carry out a group or individual leadership project in literacy education. A short description of the task force's work follows:

Overview

Members of the Task Force have worked for approximately five months to pursue the four-part charge issued by the NCTE Executive Committee. They have conferred on six occasions by teleconference, have worked in an online workspace environment, and have met face-to-face for a two-and-a-half-day meeting. They have sought out information from many sources inside and outside the Council, and have conferred candidly about many challenging questions based on organizational policy and culture.

This report is organized around the four main charges given to our task force:

- (1) Analyze the current NCTE structures intended to involve and support educators of color by looking at recruitment, retention, and advancement of members of color within NCTE;
- (2) Provide an evaluation of NCTE practices as they affect members of color;
- (3) Recommend changes in current structures and programs, or in the creation of new structures and programs needed to support members of color;
- (4) Identify successful practices used by other similar organizations to recruit, actively involve, retain, and provide avenues for leadership for people of color.

A copy that details the work of the task force will be given to the CATE Board at the February meeting, and I recommend that the Leadership Committee put it on their May agenda for discussion and to make recommendations to the board on how CATE can support members of color and encourage diversity in our leadership.

NCTE Awards:

Nominations for NCTE awards such as Intellectual Freedom, Leadership Development, Award for Classroom Excellence, Multicultural Teacher of the Dream, and Early Career Educator of Color Leadership Award will be discussed and approved at the February meeting in committees. Committee leaders should check the March agenda for awards assigned and download descriptions to present to their committee for discussion. The NCTE deadline for submission is May 1, 2008.

Elections:

On February 1, 2008, NCTE candidates for the 2008 election were announced. CATE is pleased to support the candidacy of its California candidates and urges all CATE members who also belong to NCTE to participate in this year's election. Ballots will be mailed to members in April, and completed ballots must be returned to NCTE by June 1, 2008.

The California Young Reader Medal committee met January 12, 2008 at Regency Park Elementary School in Sacramento. The presidents of the four sponsoring organizations were invited. Michelle Berry came as president of CATE. Paula Aja came as president of California Reading Association. The president of California School Library Association was also present.

Robin Radlauer-Cramer presented the reading lists for the 2009-2010 year so that members could start their reading early. The books cannot be any older than 2005. That is the cut-off date. These books will be voted on at the October meeting. Book titles were discussed that would be added to the list. We are going to try to get a poster for the 2008-2009 books from the list that was published on February 1, 2008.

The four organizations talked about their conferences this school year. CATE's conference is the last in the cycle. CRA will hold their conference in Sacramento, October 20-23, 2008. CLA will hold theirs in San Jose November 13-14 (date is not set exactly yet), 2008. CSLA will also hold their conference in Sacramento, November 20-23, 2008. And last of all, CATE will hold their conference in Santa Clara in February 2009.

The next CYRM meetings are scheduled. CRA will host the April 5th meeting at the CRA office in Costa Mesa. CLA will host the June 14th meeting in Sacramento at Regency Park Elementary School. And CATE will host the October 14th meeting in Claremont. CSLA will host the January meeting at a place to be determined.

Of course the main topic at this weekend's State Council meeting was the upcoming budget proposal. State Council put out a resolution condemning the Governor's proposed state budget. It also supplied palm cards to all members with talking points as to exactly why the proposed budget hurts California students and our members.

1. Some of the problems with the new budget were as follows:

2. It would slash \$4.8 billion from our public schools and community colleges over the next 18 months.
3. It cuts more than \$24,000 per classroom statewide.

California already ranks 46th in the nation in per-pupil spending, at nearly \$1,900 below the national per-student average.

Another action decided upon was the vote not to recommend any Presidential candidate until after the February primary. Council was originally asked to support a yes/no vote for Hillary Clinton but that was defeated and the substitute motion to wait until after the primary was passed.

Call for Manuscripts

June 2008: Teaching Literature in Peace and War (deadline May 1)

Literature can be a powerful vehicle to help readers grapple with issues and prepare us for the unknown. How have events since September 11, 2001 influenced your curriculum and classroom conversations? Does reading Wilfred Owen's "Dulce et Decorum Est," All Quiet on the Western Front, or The Things They Carried take on new meaning in a time when our country is at war? This issue of California English invites you to explore how English classrooms K-12 (think about the picture books Faithful Elephants and The Librarian of Basra) can be places for examining the human condition in times of war and peace.

September 2008: Teaching Texts Rhetorically (deadline August 1)

Teachers throughout California are finding innovative ways to use expository reading, writing, and rhetoric to prepare students for college course work. How does a rhetorical approach to texts foster critical thinking? What kinds of expository materials and themes engage student interest and promote academic literacy? How can issue-driven nonfiction help students develop the practices of fluent readers and writers and provide a foundation for principled debate and argument? Teachers who have created lessons using the CSU Expository Reading and Writing Curriculum (ERWC) are encouraged to submit manuscripts.
