Since CATEweb first began in September 15, 1997 there have been much progress. I wish to thank all those who have been so helpful in obtaining various information which has made the web site a success.

During CATE 2000, I will be taking photographs to be posted on CATEweb as a photo journal of the speakers, meetings, workshops, entertainment, and most other convention activities. The plan is to cover all possible throughout the convention with the only limiting factor being time conflicts. I will be using a megapixel digital camera which allows a much shorter time to get photos posted, and although the printed quality is slightly less than a good 35mm camera, a limited number of prints can be made available for press releases and other uses. Governor Davis' Budget Proposal

The Governor once again proposes a myriad of new programs and focus areas to provide, as he describes, "incentives for students, teachers, and schools in the area of higher expectations."

The Governor divides his new initiatives into three categories:

- Recruiting, preparing, and supporting teachers
- Rewarding student achievement and improving student performance
- Increasing the capacity of schools to meet higher expectations

Approximately \$441 million of funding for the Governor's Initiatives is from Proposition 98, but a considerable allocation--\$472 million—is from the State's General Fund in non-Proposition 98 allocations to other state agencies, including the University of California and the California State Colleges and Universities.

Teacher Recruitment and Preparation

A significant portion of the new reforms focus on teacher recruitment and the Governor's attempt to reduce the number of teachers that are on emergency credentials. About 28,500 teachers-- work with

an emergency permit rather than a regular teaching credential and that a high percentage of the teachers that are on emergency permits teach in inner city schools. They note that in Los Angeles alone, one-quarter of the city's 34,000 teaching force do not hold full teaching credentials.

The Governor's themes focus on cash awards for low-performing schools that do not have fully credentialed teachers, regional consortia to promote successful recruitment strategies, and specialized financial incentives with funding for home down payments and \$20,000 salary bonuses for those teachers that have National Board Certification and teach in low-performing schools.

The Governor also proposes significant expansion of teacher institutes and notes about 70,000 teachers will receive additional training in the budget year through these programs. He proposes Reading Institutes, English Language Learner Institutes, High School Teacher Math Institutes,

Mathematics Specialist Institute, Algebra Professional Development Institutes, and Expansion of the Subject Matter Projects administered by the University of California.

Student Achievement

The Governor also focuses on student achievement with added dollars for student scholarships and supplemental programs for students who have fallen behind in reading or math. He proposes Mathematics Instruction Academies and the California Summer School Programs in Mathematics and Science.

The Governor also proposes increased availability of Advanced Placement (AP) courses to ensure that, by the fall of 2001, "all students in California who desire to take AP courses are able to do so." One of the unique characteristics in the development of this theme is the focus on the purchase of new computers for those high schools that do not offer AP courses so that the courses may be offered on line.

Technology in Education

Technology support includes \$175 million of one-time funds to help schools purchase additional computers in the classroom, plus continuance for the fourth year of the Digital High School Program. The Governor also proposes funding to continue the expansion of school district participation in the California School Information Services (CSIS) project for electronic student data transfer.

Instructional Materials

The Governor's Budget continues significant allocations for instructional materials, most of which are at the same level as in 1999-00:

- Standardized Aligned Textbooks--The Schiff-Bustamante Instructional Materials Program--\$250 million. This will be the third year of a
 - four-year program.
 - K-12 Instructional Materials Fund--\$164.3 million
 - California Public School Library Protection Act--\$158.5 million
 - Classroom Libraries Funding--\$25 million. This program is for reading books and not textbooks.

High School Exit Exam

In January, the CDE awarded the contract for the exam items to the American Research Institute, who promised to meet the October, 2000 deadline.

At their Dec, 1999 meeting, the HSEE heard public commentary, though most of the comment on content was directed at the math portion of the test. What little comment there was on ELA focussed

on the need for a writing assessment.

Academic Performance Index

The statewide results of the API were released the last week in January. Gov Davis' news release praised the API, but also attempted to defend it. It has been criticized for its narrow focus (the use of the SAT 9 only) and for its limited database (again, the use of the SAT 9 only).

California Recommended Reading List

According to a report filed by Carol Jago, this committee met in Sacramento on January 26 and 27. Significant progress has been made towards adding recently published works to the list. Hundreds of titles have been added and old, out of print titles eliminated. It was announced that the list will now not be completed until fall 2000 (spring 2000 had been the earlier completion date) as another committee chosen by Delaine Eastin will meet to vet the committee's work.

Issues yet to be determined:

- if the list will be limited to a set number of titles
- if the list will appear in print, on the web, or both
- how often the list is to be updated
- if titles on the list will have a lexile score attached
- how field review will be conducted

Committee's concerns include

- the need for more classical literature on the list
- the need for more text in the grades 3-5 selections
- the need for more contemporary drama
- the absence of the two CABE representatives as their counsel and input are sorely needed

Note from Carol: "The committee meets again on March 15 and 16 and has set a fourth meeting date for April 26 and 27. In an effort to make our representation of CATE truly representative, please let us know if you feel strongly about any of these issues."
